Narrative: On 6-4-18 Col. Lee Anderson delivered Exhibit 1 to me. Col. Anderson advised me that he had recovered the device from Fred Corder during his interview with him. Also on this date Det. SSgt. Kelly Brown provided me with a signed search warrant authorizing the examination of this device in connection with an ongoing investigation of an Indecent Behavior with Juveniles case.

A 16 y/o female had stated that she had allegedly exchanged phone numbers with Corder while he was assigned as an SSO to Donaldsonville High School. During this time frame, Corder allegedly told the juvenile that he could bring her home and she could "suck his dick." The juvenile declined and stated the two had exchanged pictures of tattoos and she had also sent him a picture of her breast.

I was advised that on 6-4-18 a controlled meeting between Corder and the juvenile was arranged during this investigation. SSgt. Brown requested the recovery of any and all data; specifically requesting any photographs, SMS, MMS or call logs between the two involved parties.

Processing

1. Exhibit 1: was processed using APSO Digital Forensic protocols where 4.48 GB of data was recovered. (No Damage Noted)

Results and Conclusions

After reviewing the recovered data, I was unable to locate any communications on Exhibit 1 between the two involved parties. The case detectives and the juvenile were unable to provide the juvenile's phone number to her stating she had lost the phone and couldn't remember her number.

On 6-6-18, due to the lack of locating any apparent contact between the two parties and not being able to identify the juvenile's phone number, I obtained a search warrant for the call detail records of Fred Corder's phone number from AT&T. This search warrant was based off the information provided to me by Det. SSgt. Brown. On 6-8-18 I received a return from AT&T in reference to this case. Based on the dates of 2-19-18 to 3-2-18, Corder's temporary assignment as SSO to Donaldsonville High School, I began to narrow down all incoming and outgoing phone numbers in the received call detail records. On 6-26-18 after narrowing phone numbers from the call detail records to 18 phone numbers, I notified SSgt. Brown who then had the juvenile brought to his office where he and I spoke with her. I asked her to take a look at the list of 18 phone numbers and she immediately pointed out the third number on the list.

Using this phone number I further refined the call detail records to eliminate all communications except for those with this phone number. I found that between the dates of 2-28-18 through 3-20-18; 68 voice calls and 743 SMS messages were exchanged between Exhibit 1 and the phone number identified by the juvenile as belonging to her. The last voice call occurred on 3-17-18 at 2:44 PM. I further attempted to locate the identified phone number on Exhibit 1 to no avail. This appeared to be due to a selective deletion by the end user, based off the fact that all phone call logs prior to 3-8-18 were not recoverable due to being overwritten.

"Journey Data" regarding the controlled meeting on 6-4-18 was recovered from the phone. The "Journey Data" showed Corder's travel at 11:44 AM on 6-4-18 from US 61 and LA 74 to Depen St. off of LA 74, the location where the meeting between he and the juvenile was to take place. In addition I recovered the text messages which were sent back and forth between Corder and the case Detectives to arrange the meeting. It should be noted that the entire conversation regarding this meeting was deleted by the end user of the device.

The context of this conversation was such that Corder requested to meet with the juvenile. Corder inquired about the juveniles living arrangements and address. After requesting the meeting, case detectives apparently asked Corder "Do u want oral or other stuff". They then asked "Do u wanna meet at the store are by the bridge". Corder didn't respond to this text in regards to sex, instead he stated "I'll meet you at the store"

Additionally, I recovered two pictures, one of what a appeared to be a male subjects lower leg with a tattoo, the second picture was of a females breasts. These images matched the descriptions

given to me of possible images that had been sent between Corder and the juvenile. These images were printed and provided to SSgt. Brown who then showed them to the juvenile. According to SSgt. Brown, the juvenile identified both images as being the images that she had exchanged with Corder.

Note: Due to file size, electronic delivery restrictions, and end user limitations; the full PDF export and proprietary or raw forensic image files were not included but are available upon request. The full PDF provides a visual representation of all data extracted. The original physical evidence was returned to Col Lee Anderson who then returned the device to Fred Corder.
