On the 07-05-2022 plaintiff file motion and sent letter with attached supporting documents to the Judge's chamber terminating attorney Brown off my case. (REC. at NO. 100) : in-which, attorney Brown was very aware of.

On the 07-05-2022 plaintiff filed motion to vacate any and all pending matters involving

this case ( Rec. at NO. 101 ):in which, attorney Brown was very much aware of.

On the 07-05-2022 plaintiff filed expedited motion for hearing terminating attorney

Brown from this case ( Rec. at NO. 102 ):in which, attorney Brown was very much aware of.

On 07-07-2022 attorney Brown filed motion to withdraw as counsel of record (Rec. at NO.99)

On 07-10-2022 it came to my knowledge that attorney Brown had filed motion for extension of time to file response/ reply to defendant's motion to compel (Rec. at No. 104 & 105) without plaintiff knowledge and without plaintiff's permission: in spite, to plaintiff's Terminating him and plaintiff's pending motion to vacate any and all pending matters involving plaintiff's case. (Rec. at NO. 101-103)

Plaintiff have file suit against attorney Brown, Judge, J. Zainey and Judge J. Meerveld and other parties and they all have been served a copy of suit.

On 07-20-21-2022 Judge J. Zainey recused himself and cancelled pending hearing that was set for July 26, 2022: in which, was the right thing to do according to the law for the better interest of justice. ( Rec. at No. 109 )

On the 07-20-2022 Magistrate judge Meerveld was served a copy of suit against her, but on 07-26-2022 Judge J. (Rec. at No. 114) Plaintiff believes that judge Meerveld should have cancelled this motion also according to the law and

for the better interest of justice on the behalf of plaintiff.

Plaintiff advises the court that Attorney Brown have / has no right to continue filing Motion(s) and or no more right to respond to more motions pertaining to this case.

Plaintiff advises the court that if Attorney Brown files any more motions and or response pleading into this court he needs to show this court while he should not be sanction by this court.
